



PRE-AUTHORIZED DEBIT (PAD) MEMBERSHIP PLAN AGREEMENT

I/we authorize Renfrew Golf Club Ltd, and the financial institution designated (or any other financial institutions I/We may authorize at any time) to begin automatic withdrawals as per my/our instructions for monthly regular membership recurring payments per the club's membership contract and/or one-time payments from time to time, for payment of all charges arising under my/our Renfrew Golf Club account(s). Regular monthly payments for the full amount of service delivered will be debited to my/our specified account on the 1st day of each month. Renfrew Golf Club Ltd will obtain my/our authorization for any one-time or sporadic debits.

This authority is to remain in effect until Renfrew Golf Club Ltd has received written notification from me/us of its change or termination. This notification must be received at least thirty (30) business days before the next debit is scheduled at the address provided below. I/We may obtain a sample cancellation form, or more information on my/our right to cancel a PAD Agreement at my/our financial institution or by visiting www.payments.ca

Renfrew Golf Club Ltd may not assign this authorization, whether directly or indirectly, by operation of law, change of control or otherwise, without providing at least 10 days prior written notice to me/us.

I/we have certain recourse rights if any debit does not comply with this agreement. I/we have the right to receive reimbursement for any PAD that is not consistent with this PAD agreement.
