This policy applies to all Renfrew Golf Club players, including both Members and Public players.

By booking tee times, maintaining a Member profile, or providing a credit card to Renfrew Golf Club ("RGC"), I acknowledge and agree to the following:

Credit Card Requirement

I understand that a valid credit card is required to secure and hold tee time reservations at RGC.

For Public bookings, a valid credit card must be provided at the time of booking. I understand that the card will not necessarily be charged in advance, but may be charged at check-in or where applicable for late cancellations, no-shows, unpaid balances, or other amounts owing in accordance with RGC policies.

For Member bookings, I authorize RGC to securely maintain credit card information associated with my Member profile for the purpose of securing tee time reservations and resolving applicable unpaid balances, late cancellations, or no-show charges.

Cancellation & No-Show Charges

I acknowledge that tee time bookings are subject to the Club's Cancellation & No-Show Policy, RGC-OPS-001.

I understand that charges may be applied to the credit card associated with a booking where a player fails to attend, cancels outside the permitted cancellation period, or otherwise becomes responsible for a charge under Club policy.

Member Charge Accounts

I understand that charging privileges are not automatically provided to all Members. Members wishing to operate a Club Charge Account must register for and receive approval from RGC. Approved Club Charge Accounts will be invoiced through the Club's regular monthly billing process.

Unpaid Accounts, Merchandise & Food and Beverage Charges

I understand that any unpaid merchandise, golf, cart, food and beverage, or other Club charges remain my responsibility. Where an outstanding amount remains unpaid, RGC may contact me and provide an opportunity to settle the account directly. Where permitted under this agreement and Club policy, I authorize RGC to charge an outstanding balance to the credit card maintained on my account or associated with the applicable transaction or booking.

Group Bookings

I understand that the individual making a group booking may be required to provide one valid credit card to secure the entire reservation. Where I make a booking on behalf of other players, I understand that I am expected to make those reservations with the knowledge and consent of the individuals included in the booking.

A Member will not normally be held financially responsible for another player's no-show. However, I acknowledge that if RGC determines that tee times were reserved for players without their knowledge or consent, including the use of placeholder or speculative bookings, the individual who made the original reservation may be held financially responsible for resulting no-show charges.

Club Oversight

I acknowledge that RGC's Proshop and management may regularly review cancellations, no-shows, unpaid accounts and booking activity. Where appropriate, RGC may take action including contacting the individuals involved, flagging an account, applying applicable charges, restricting booking privileges, or referring repeated or serious concerns to Club management or the Board of Directors.

24-hour Cancellation Window

The Club will implement a 24-hour cancellation window for all tee time bookings.

Members:

- Members and their registered guests must cancel tee times no later than 24 hours prior to the scheduled tee time using the online booking system.
- After the 24-hour online cancellation window, members may still cancel by phone or in person with the Pro Shop up to 2 hours prior to the scheduled tee time.
- Cancellations made inside this 2-hour window due to reasonable circumstances will be forgiven, and no cancellation or no-show charge will apply, provided the Pro Shop has been notified.
- Each Member will receive one courtesy warning for:
 - A missed tee time, or
 - A registered guest failing to show.
- Following the courtesy warning, Members will be charged 50% of the posted rack rate for all booked players, Member and Public players (guests) the applicable time of day for:
 - No-shows, or
 - Late cancellations where the Pro Shop was not notified within the permitted timeframe.

PLAYER / MEMBER ACKNOWLEDGEMENT

By signing below, I confirm that I have read and understand the Renfrew Golf Club Credit Card Preauthorization & Booking Policy. BACKSHOP CLUB STORAGE ACKNOWLEDGEMENT & AGREEMENT

By choosing to store my golf clubs, golf bag and/or other golf equipment in the Renfrew Golf Club ("RGC") Backshop, I acknowledge and agree to the following:

1. **Storage at Member's Risk**

I understand that my golf clubs, bag and any personal belongings are stored in the RGC Backshop at my own risk. While RGC will take reasonable care in the handling and storage of equipment, the Club is not responsible for loss, theft, damage or deterioration of personal property while being stored on Club premises, except where otherwise required by law.

2. **No Food or Perishable Items**

I understand that no food, snacks, beverages or other perishable items are to be left in my golf bag or stored equipment at any time.

3. **Pest Damage**

I acknowledge that food or other materials left in golf bags may attract mice, insects or other pests. I accept responsibility for ensuring my golf bag is free of food and understand that RGC will not be responsible for damage to my golf bag, clubs, clothing or other personal property caused by pests where food or other attractants have been left in or around my equipment.

4. **Valuables and Personal Property**

I understand that cash, jewellery, electronics, medications, keys or other valuable personal belongings should not be left in my golf bag or Backshop storage area.

5. **Condition of Equipment**

I am responsible for periodically inspecting my golf bag and equipment and for bringing any concerns regarding storage or handling to the attention of RGC staff as soon as possible.

6. **End-of-Season Removal**

I agree to remove my equipment from the Backshop by any deadline communicated by RGC. Equipment remaining after the designated storage period may be subject to additional storage arrangements or fees as determined by the Club.
